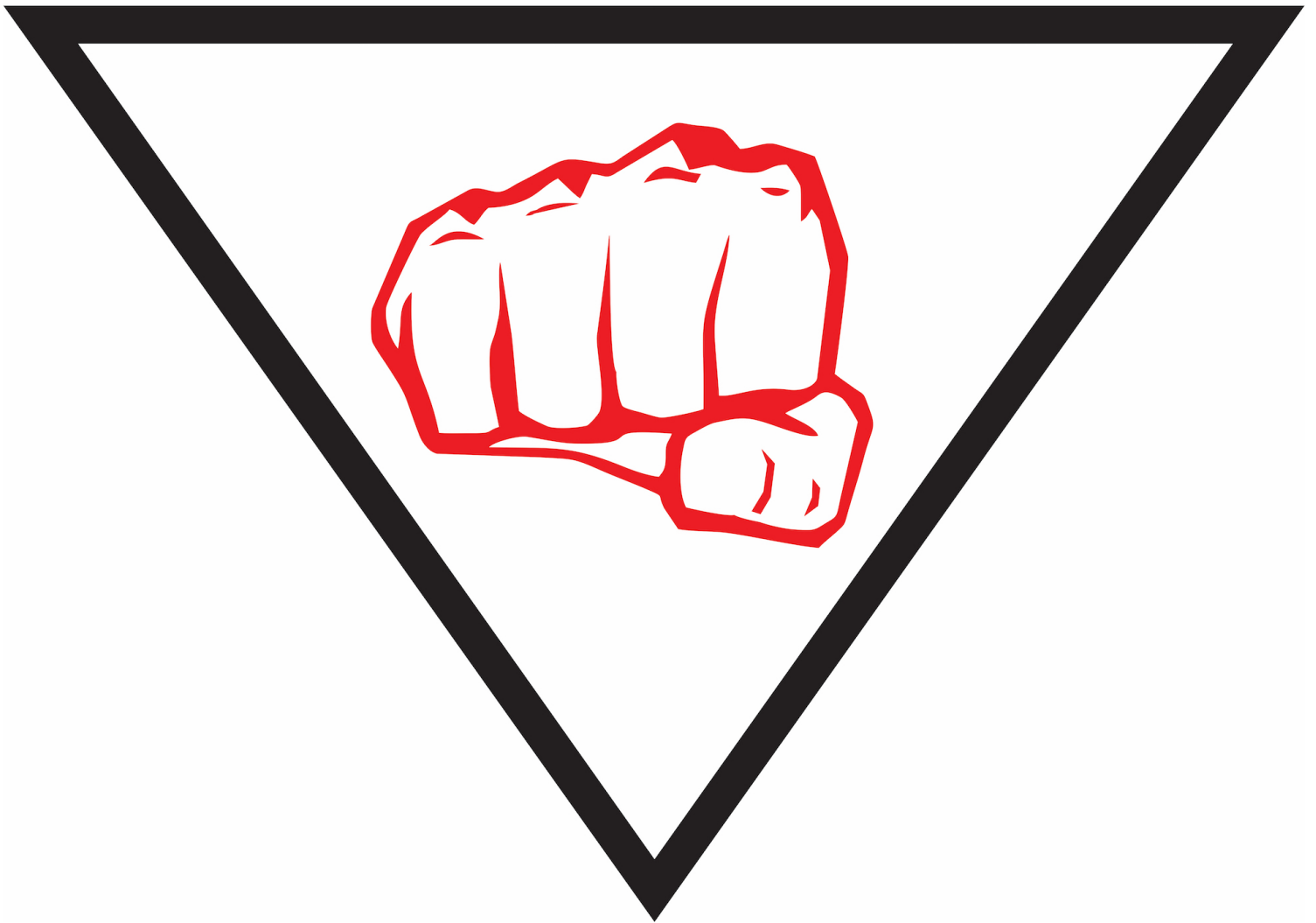

- 3) All overdue amounts shall bear interest at 2.5% over the prime overdraft rate charged by the creditor's banker's from time to time, such interest to be reckoned monthly in advance from due date to date of payment.
- 4) Notwithstanding delivery, ownership of goods shall not pass to the applicant until payment therefore has been made.
- 5) In the event of the applicant defaulting in making payment of any amount that has become due and payable without notice to the applicant. Should the creditor institute proceedings against the applicant. The applicant shall be liable for all the Creditors costs incurred, including, but not confined to collection commission.
- 6) The applicant will notify the creditor, in writing within 7 (seven) days of any change of address, ownership or directors of the applicant business.

SURETYSHIP

Deed of Surety ship

I, by my signature hereto (which appears below) do, in addition to the above, hereby bind myself in my private capacity as surety for and co-principal debtor in solidum with the applicant in favour of the creditor for the due performance of any obligation of the applicant and for the payment to the creditor by the applicant for any amount which at any time become owing to the creditor by the applicant from whatsoever cause arising. The surety ship shall be a continuing covering guarantee/surety which may only be cancelled in writing by the creditor and then, only provided that all sums then owing by the applicant (whether due or not) to the creditor have been paid in full.

I hereby renounce the benefits of the legal exceptions “non causa debiti” ” ordinis seu excussionis et divisionis” and “cession of action” with the force, meaning and effect of which I declare myself to be fully acquainted. I furthermore bind myself irrevocably to all of the terms and condition of clauses 1,2,3,4 and 6 aforesaid. If more than one person has appended his or her signatory hereto, there shall come into existence a separate, distinct and independent contract of surety ship, which is brought into existence by each signatory hereto. If for any reason this surety ship is not binding (for whatever reason) on any one signatory, then the obligation of the remaining signatories shall never the less be and remain of full force and effect. The applicant and I warrant that the information submitted is true and correct in all

respects.
